Financial Regulations Version No.4

**Terms and conditions about the payment of fees and reimbursement of costs  
to the Educational institution**

Riga, February 7, 2025

**1. General Provisions**

1. Lycée français international Jules Verne de Riga, Educational Institution Registration No 3913803640 (hereinafter - the Educational Institution), is an Educational Institution founded by the Association "APECEF", Reg.No 40008120468 (hereinafter - the Association). The members (founders) of the Association are the legal guardians of Students. The Legal Guardian who signs the Agreement for the education of the Student(s) in the Educational Institution (hereinafter referred to as the Agreement) becomes a member of the Association. In accordance with the International School Law, the activities of the Association and the Educational Institution shall be financed by the payments of the members (legal guardians of students).
2. The Regulations determine the fees to be paid by the Legal Guardian in order to ensure the financing of the activities of the Educational Institution, as well as the terms and conditions for the payment of these fees and reimbursement of costs.
3. By signing the Agreement, the Legal Guardian undertakes to respect and comply with these Regulations.
4. All the payments referred to in the Regulations are exclusive of value added tax. If changes in legislation so require, value added tax may be applied to the services provided in accordance with the procedure laid down by law.
5. The Regulations are permanently available at the premises of the administration of the Educational Institution and are published on the website of the Educational Institution ([www.lyceejulesverne.lv](http://www.lyceejulesverne.lv)).

**2. Registration fee (membership fee)**

6. The Legal Guardian has an obligation to pay the registration fee in the amount set out in the Annex to these Regulations. The registration fee shall be payable for each academic year, and is payable per family, except for the first registration fee, which shall be payable for each child at the moment when the Legal Guardian first becomes a member of the Association or when he/she becomes a member of the Association anew if more than one year has elapsed since leaving the Association.

7. The registration fee is defined and approved as provided by the Statute of the Association<sup>1</sup>. The registration fee is payable once a year before the respective school year, in accordance with the terms of the Agreement, and the payment is applied to the respective school year. If the Legal Guardian concludes the Agreement in the middle of the school year, the registration fee for the respective incomplete school year shall be paid in full.
8. The registration fee is non-refundable. If the registration fee has been paid but the Student(s) do not commence the studies in the planned time of commencement of the studies, the registration fee is not reduced or refunded and is not transferred (applied) to the next study year.
9. In exceptional cases, the Board of the Association may decide to reduce, transfer or refund the Registration Fee.
10. If the Legal Guardian is an employee of the Educational Institution, a 45% discount on the registration fee shall apply in accordance with the decision of the General Assembly of Association Members of April 25, 2013. Upon termination of the Legal Guardian's employment with the Educational Institution, the Legal Guardian shall pay all fees in full in accordance with the Annex to these Regulations (the 45% discount shall not apply) starting from the next month after termination of his/her employment with the Educational Institution.

### 3. Study fee

11. The Legal Guardian has an obligation to pay the study fee in the amount set out in the Annex to these Regulations. The tuition fee is the monthly fee for each month of the school year (September to June inclusive) and for each Student of the family.
12. The study fees are set and payable for each month and each Student regardless of the number of school days within the respective month, the form in which the learning takes place (face-to-face or distance) and the attendance of the Student(s) (regardless of the reason). In the event of absence of the Student(s), regardless of the reason, the study fee shall not be reduced and the Legal Guardian shall be obliged to pay it in full regardless of the number of lessons/days the Student(s) actually participated in the learning (face-to-face or distance).
13. The study fee, including the discounts, if they are applicable, shall be determined and approved in accordance with the Statute of the Association.<sup>2</sup>
14. If several children of the same family are enrolled in the Educational Institution, a special tariff is applied to study fee of the second and subsequent Students from the same family. The order is determined by age, starting with the oldest child. A study fee discount may be applied if the Legal Guardian prepays the tuition fee for a school trimester or half a school year by giving prior notice to the Educational Institution in accordance with the procedure established by the Educational Institution.

15. If the Legal Guardian is an employee of the Educational Institution, a 45% discount on the tuition fee shall apply in accordance with the decision of the General Assembly of Association Members of April 25, 2013. Upon termination of the Legal Guardian's employment with the Educational Institution, the Legal Guardian shall pay all fees in full in accordance with the Annex to these Regulations (the 45% discount shall not apply) starting from the next month after termination of his/her employment with the Educational Institution.
16. Conditions for the payment of the study fee:
  - 16.1. The Legal Guardian shall pay the study fee for each month of the school year from September to June, included. The study fees are not payable for July and August (during summer holiday) except if the school calendar of the respective school year is changed (in such a case the Association informs the Legal Guardian about the changes in respect to the payment of study fee);
  - 16.2. If the Student/s use/s the service of supervised stay at school or camps during school holidays, including summer holiday, the Legal Guardian must pay the respective fees according to the tariffs announced in advance and according to the payment terms and due dates;
  - 16.3. The Legal Guardian shall pay the study fee every month. The Legal Guardian may pay the study fee in the form of pre-payment for the trimester or for the half of school year by paying a reduced study fee (discount) specified in the Annex of these Regulations. If the Legal Guardian impedes the term of payment of the study fee, study fee discount is cancelled but instead the Legal Guardian shall pay the monthly study fee in full amount
  - 16.4. The frequency of payment of the study fee chosen by the Legal Guardian (each month or in the form of prepayments for the trimester or half year) is indicated in the Agreement. If, during the course of the school year the Legal Guardian wishes to change the frequency of payment of study fees, the Legal Guardian shall inform the Educational institution thereof, and the Parties shall execute in writing an Amendment to the Agreement. If a discount has been applied to the tuition fee prepayment originally selected, the discount will be lost upon switching to another frequency and the Legal Guardian is obliged to pay the study fee in full.
17. If a municipality's or state's financial support (co-funding) is granted for the Student/s' pre-school education, the study fee payable by the Legal Guardian is decreased by the amount of financial support (co-funding) paid by municipality and/or state. In other cases the study fee is reduced only if such study fee reduction is expressly specified in the external regulatory enactment or in the agreement which the Educational Institution has concluded with the institution granting financial support (co-funding).

#### **4. Capital fee**

18. The capital fee is a parents' contribution to the special reserve fund directed at the planned investments in the school's infrastructure. It will also serve the purpose of accumulating equity for further investments or opportunities such as downpayment for a new building. It can also serve as a safety reserve in case of unforeseen circumstances. The use of the fund is at the discretion of the Management Board of the Association.

19. The Legal Guardian has an obligation to pay the capital fee in the amount set out in the Annex to these Regulations. The capital fee shall be payable for each academic year, and is payable per family.
20. The capital fee is defined and approved as provided by the Statute of the Association<sup>3</sup>. The capital fee is payable once a year before the respective school year, in accordance with the terms of the Agreement, and the payment is applied to the respective school year. If the Legal Guardian concludes the Agreement in the middle of the school year, the capital fee for the respective incomplete school year shall be paid in full.
21. This fee shall be payable by the Legal Guardian in one instalment before the beginning of each school year in accordance with the invoice issued, but no later than by July 15.
22. The Legal Guardian shall have the right to request that the capital fee be split into several instalments and added to the study fee invoice in accordance with the study fee payment frequency (monthly, trimester or half-yearly) chosen in the Agreement, by sending such a request to the e-mail address [directeur.financier@lyceejulesverne.lv](mailto:directeur.financier@lyceejulesverne.lv) no later than by June 15.
23. The capital fee is non-refundable in the event of withdrawal or otherwise.
24. In exceptional cases, the Board of the Association may decide to reduce, transfer or refund the capital Fee.

## 5. Costs of study materials

25. The Legal Guardian has the obligation to pay the costs of the study materials for the educational process<sup>4</sup> in accordance with the Annex to this Regulation. The Legal Guardian shall pay these expenses for each Student.
26. These expenses shall be paid by the Legal Guardian in one instalment before the beginning of each school year in accordance with the provided invoice, but no later than by 15 July.
27. Purchased study materials remain at the disposal of the Educational Institution and are used to ensure the educational process.

## 6. Catering costs

28. The Legal Guardian has the obligation to pay for the costs of catering for each Student<sup>5</sup>, payable in each subsequent month in respect of the preceding month:
  - 28.1. the amount of the costs - the amount per day, based of catering contract, and taking into account the actual number of days of catering in the respective month when the Student(s) attended the Educational Institution. This amount per day is not divisible. These costs shall be calculated by adding the number of days the Student(s) attended the Educational Institution in the previous month and multiplying by the amount specified in

this subparagraph or in the pricelist that is published on the website of the Educational Institution.

For the school year 2025/2026, the amount of the catering costs will be determined before the start of the school year in accordance with the outsourced service contract.

29. The Legal Guardian is informed of any changes in these costs at least one month in advance.
30. If municipal and/or state support (co-financing) is granted for the school meals of the Student(s), the amount of costs of catering is decreased in the amount of the municipal and/or state support (co-financing) received.

#### **7. Fee (costs) for final examinations of the educational cycle**

31. The Legal Guardian has the obligation to pay the fees ( costs) for the final exams for the primary, intermediate and secondary stages of education<sup>6</sup> in accordance with the Annex to these Regulations.

#### **8. Fees for additional services in the pedagogical area**

32. If the Educational Institution finds it necessary to involve additional teacher(s) or other pedagogical personnel in the education of the Student(s), and/or assign additional lessons, it informs the Legal Guardian about it, providing reasons for such necessity, and the Parties shall agree on such additional service and its payment, as set out in the Annex to these Regulations.
33. If the Student(s) has/have not successfully completed the learning objectives of the Programme, the Legal Guardian is informed about the Student's failure to do so, and the Educational Institution has the right to assign additional lessons to ensure necessary academic progress, if necessary, setting an additional fee for this service. The Legal Guardian has an obligation to ensure the Student's attendance of such additional classes and pay for them.

#### **9. Insurance fees**

34. If the Legal Guardian at the signing of Agreement shall choose to ensure the Student's civil liability insurance and insurance against accidents through the Educational Institution, the Legal Guardian shall be liable to pay the cost of such insurance in accordance with the actual expenses as notified to the Legal Guardian by the Educational Institution.

#### **10. Expenses for excursions and school trips**

35. The Legal Guardian shall be liable to cover the costs of excursions and school trips organized within the educational framework, including transportation costs, in accordance with the actual amount of the costs notified by the Educational Institution prior to the event in question.

If the excursion or school trip is directly related to the compulsory requirements of the curriculum, the expenses shall be covered by the Educational Institution.

#### **11. Services of extracurricular activities (clubs)**

36. The Educational Institution may offer optional interest education services by announcing the after school activities (clubs) programme for the respective trimester and the amount of the fee/s for such interest education services<sup>7</sup>. If the Legal Guardian shall apply for the participation of the Student(s) in the offered extracurricular activities (clubs), the Legal Guardian shall pay the fee for the interest education services in accordance with the terms and conditions stipulated and announced by the Educational Institution.

#### **12. Fee for supervised stay during afterschool hours (Garderie service)**

37. The Legal Guardian shall pay a fee for supervised stay of the Student(s) during afterschool hours from 15:30 -18:30 (Garderie service)<sup>8</sup>, if such is offered by the Educational Institution and the Student's Legal Guardian applies for participation. The Educational Institution shall determine the fees for the supervised stay of the Student(s) at the Educational Institution during afterschool hours from 15:30 -18:30 (Garderie service) according to terms and provisions of the Agreement and the Annex of these Regulations.

#### **13. Fees for supervised stay / recreational or sports camp during school holidays (if offered)**

38. The Legal Guardian shall pay a fee for supervised stay of the Student(s) and/or recreational and sports camps during school holidays<sup>9</sup>, if such is/are offered by the Educational Institution and the Student's Legal Guardian applies for participation. The Educational Institution shall determine the fees for the supervised stay of the Student(s) at the Educational Institution or participation in a day camp organised by the Educational Institution during the school holidays according to terms and provisions of the Agreement and the Annex of these Regulations.

#### **14. Contractual penalty for late collection of the Student(s)**

39. If the Student(s) is/are collected from the Educational Institution after its working hours or after 15:30 if the Student(s) is/are not registered for the Garderie after school service, the Legal Guardian has the obligation to pay the penalty<sup>10</sup> at the request of the Educational Institution for each time and for each Student collected late. The contractual penalty shall be included in the following month's invoice.

#### **15. Payment of fees and expenses and penalty**

40. By the 7<sup>th</sup> day of each month, an electronic invoice is sent to the e-mail address indicated by the Legal Guardian, indicating the fees and expenses payable in accordance with the Agreement and the present Regulations and its Annexes.
41. The Legal Guardian has an obligation to pay the invoice within the deadline indicated thereon, but no later than within 5 (five) days from the day of receiving the invoice, executing a money transfer to the account indicated on the invoice. The Legal Guardian is deemed to have received the invoice on the day of its sending, unless the Legal Guardian until the end day of the respective month has notified the Administration of the Educational Institution that the invoice has not been received. The payment day of the fees stipulated by the current Agreement is the day when the money is received in the bank account indicated on the invoice.
42. If the issued invoice is erroneous, the Legal Guardian has a right to request rectification of the shortcomings, giving the justification for that request.
43. In the event of delay in the payment of fees and expenses specified in the Agreement, the present Regulations and its Annexes, a penalty of 10% of the amount not paid in due time may be imposed.
44. Due to late payment of services provided by third parties, the Legal Guardian pays for both the services rendered and the contractual penalty or default interest determined by the respective service provider.
45. If the Legal Guardian shall encounter financial difficulties impeding payment of fees and expenses to the Educational Institution, the Legal Guardian is obliged to enter into a dialogue with the Educational Institution in a timely manner in order to agree on a solution (e.g. setting up a debt repayment schedule).
